### **TCA Receives Funding for Cultural District Grants**

Since our last update, House Bill 1, the bill containing the Texas Commission on the Arts' appropriation for fiscal years 2016 and 2017, was reviewed by Governor Abbott during his veto period. As passed by the Senate and House, HB 1 included a rider that provided an additional \$5 million to TCA's annual budget.

Governor Abbott approved the additional \$5 million for fiscal year 2016, but issued a line-item veto on the \$5 million budgeted for fiscal year 2017. His explanatory note to the line-item veto reads, "A fiscally conservative approach to governing requires limiting the rate of growth in state spending. Funding for cultural tourism grants would be substantially increased from \$1.3 million in FY 2014-2015 to \$11.3 million in FY 2016-2017. I therefore object to and disapprove of one year of this appropriation." Even without the vetoed amount, the addition of the new \$5 million for Cultural District grants is a significant increase to TCA's budget and its capacity to impact cultural tourism in the state.

The new funds are specifically for cultural tourism grants and would allow TCA to offer a grant

program for designated Cultural District marketing, infrastructure, and events. The new funds will be added to TCA's base appropriation, which is budgeted at \$13 million over the next biennium, in line with TCA's budget for the current biennium.

The legislation stipulates that the amount provided to TCA would first need to be certified by the Texas Comptroller as generated by Cultural Districts in Texas. TCA staff is working with Texas Comptroller staff to determine the way that the funds would be certified. TCA is currently developing grant program guidelines and deadlines around the funding for Cultural Districts.

The Texas Commission on the Arts is excited about this opportunity to better address the arts' impact on tourism and the state's economy through the Cultural Districts program, and grateful for the support of legislators and arts advocates toward this effort.

### **TCA Grant Opportunities and Updates**

#### **Upcoming Grant Deadline**

TCA has updated the **Arts Respond Performance Support** application form and posted it online. Organizations wishing to apply for the next deadline for this program, August 3, 2015, may work on their online applications now. As always, the TCA staff is happy to discuss your organization's goals and eligibility to determine which programs are right for you. You may also request that a TCA staff member review your application and provide feedback. Ideally, these requests would be made at least two weeks before the application deadline.

The Arts Respond Performance Support program provides professional artist fees to Texas nonprofits, schools, colleges, and units of government for hiring an artist from the <u>Texas Touring Roster</u> to do a performance. These applications are funded based on a percentage of contracted fees.

Activity dates must start: Between September 1, 2015 and December 14, 2015

Application deadline: Midnight on August 3, 2015

Funding decisions on both the Arts Respond Performance Support applications and the Arts Respond Project applications will be made at the September 2 Commission meeting.

If your organization applied for the Arts Create grant program for the March 1 or 15 deadline, nine discipline-specific panels met in Austin between April 27 and May 21 to review and score these grant applications. You can call the program staff to get your numerical panel score now. Panel comments, scores, and recommended funding amounts will be posted in your online account in August (TCA will send an email to alert applicants when this is done). Funding decisions on Arts Create applications will be made at the September 2 Commission meeting. ## **New Arts & Digital Literacy Institute**

TCA's friends at the Texas Cultural Trust are convening their first Arts & Digital Literacy Institute. The Arts & Digital Literacy initiative is a project-based fine arts curriculum for high school students that bridges the gap between fine arts education and technology instruction, and establishes the connection between traditional arts education and digital media.

Held August 4-6, 2015 at Round Rock High School, the Institute will provide intensive training and professional development on all Arts & Media Communications courses, a suite of innovative courses that teach digital literacy through the fine arts. The courses create learning experiences that develop students' capacities for critical thinking, creativity, imagination, and innovation. The curriculum is designed to develop students' media literacy, providing integrated,
